MEETING MINUTES CAPITOLA COMMISSION ON THE ENVIRONMENT

Vice-Chair Kristin Sullivan called the meeting to order at 6:00 p.m.

1. CALL TO ORDER & ROLL CALL

2. WRITTEN AND ORAL COMMUNICATIONS:

Amie Forest suggested water issues become a regular agenda item for on-going discussion.

3. APPROVAL OF MINUTES: January 22, 2014.

Bruce Arthur: Page 2, Item 5e, paragraph 6: "Bruce Arthur suggested the content of the brochure be updated and expanded to educate the public beyond information focused on Soquel Creek, and that distribution of the brochure should be citywide.

Kristin Sullivan made a motion to approve the January 22, 2014 meeting minutes with changes. Bruce Arthur seconded. Motion passed 3-0

• Improve the upper terrace area of the Rispin property with a demonstration native plant garden incorporating a rain catchment system.

• Seek funding from the Arts Commission for signage; and the water districts for rain barrels and supplies.

Bruce Arthur will contact Steve Jesberg to inquire on the feasibility of this project. Maddie Marlatt will contact Mike Arnone for landscape architectural input.

Subject: Climate Action Plan Status

The City of Capitola is in the process of developing a Climate Action Plan (CAP) to meet State greenhouse gas (GHG) reduction goals pursuant to Assembly Bill 32 and Senate Bill 375. The CAP will establish goals, principles, and strategies to reduce the City's GHG emissions, conserve energy and natural resources, and to prepare the community for the expected effects of global warming. The CAP will include a list of emission reduction measures organized by sector (transportation, land use, energy, and waste) and timeframes for implementation.

Implementation of the CAP will advance sustainability policies in the draft General Plan Update and will promote community values, including protecting our water and air resources; reducing the waste stream to landfills; improving energy efficiency; encouraging alternative transportation options and reducing automobile dependency; and creating a healthy and livable community. Development of a CAP requires the City to establish an inventory of existing and projected GHG emissions and to develop strategies to achieve a 15% GHG emission reduction by 2020.

The City has an existing contract with Placeworks (formerly DC&E/The Planning Center) to complete the CAP. In addition, the AMBAG Energy Watch Program has provided a draft Energy Action Strategy and a draft 2010 Baseline Community-wide GHG Emissions Inventory to assist the City with preparation of the CAP.

The CAP was initially planned to be completed in conjunction with the General Plan Update. Due to resource limitations, the CAP schedule was subsequently delayed to allow staff to focus its efforts on completing the General Plan. The General Plan Update will be considered for adoption by the City Council on May 8. Following adoption, staff intends to turn its focus toward completion of the CAP and updating the City's zoning ordinance.

At this time staff would like to finalize the COE's planned input and review for the CAP. Staff will return to the COE this summer to offer a more detailed presentation of the CAP and to seek their input and recommendations on potential GHG emission reduction measures and other CAP related issues.
